

PUBLICATION OF GROSS SALARIES  
 NIOBRARA COUNTY, WYOMING

Pursuant to Wyoming Statute 18.3.516(b)(i) relating to publication requirements for local government: Each Board of County Commissioners shall publish, within sixty (60) days after the end of each fiscal year, the name, position and gross monthly salary of each full-time employee and each elected official. All salaries are listed as gross monthly salaries or actual monthly wages and do not include any fringe benefits such as health insurance costs, life insurance benefits and pension plans. These salaries do not include any overtime that the employee may earn which would be paid by the county.
