

**COMMISSIONERS' PROCEEDINGS**  
**NIORARA COUNTY, WYOMING**  
**July 18, 2006**

The Niobrara County Commissioners reconvened for their regularly scheduled meeting on July 18, 2006 in the Commissioners' Room of the Niobrara County Courthouse. Present were Commissioners Tom L. Wasserburger, Richard A. Ladwig, Ronson B. Pfister and County Clerk Becky L. Freeman.

Road & Bridge- Road & Bridge Foreman Fred Thomas met with the Commissioners and updated them on Road & Bridge issues. He noted that the Rural Fire Department had requested his assistance in blading weeds at their location as they are constructing a new building. The Commissioners advised him to handle it as was done for the Weed & Pest building.

Minutes- Ladwig moved, seconded by Pfister, to approve the minutes of the July 6, 2006 meeting. **MOTION CARRIED.** Ladwig moved, seconded by Wasserburger, to approve the minutes of the Public Hearing on July 17, 2006. **MOTION CARRIED.**

Catering Permit- Pfister moved, seconded by Ladwig, to approve the catering permit for the Pub LLC. to sell alcoholic beverages at the Beer Garden to be held at the Niobrara County Fairgrounds on August 4, 2006. **MOTION CARRIED.**

State Library Division- The Commissioners received a letter from the Dept. of A & I, State Library Division regarding verifications and instructions for distribution of library funding. Upon recommendation from the library board, the Commissioners chose to have the checks made payable to the Niobrara County Library and mailed to the library. All required reports will be the responsibility of the County Librarian.

RESOLUTION 06-08 Adoption of FY 2007 Budget- Ladwig moved, seconded by Pfister, to approve **RESOLUTION 06-08 Adoption of FY 2006-2007 Budget.** **MOTION CARRIED.** A complete copy of the resolution and budget is on file at the clerk's office.


RESOLUTION 06-09- Tax levies for FY 2007 Budget- Pfister moved, seconded by Ladwig to adopt **RESOLUTION 06-09 Tax Levies for FY 2006-2007 Budget.** **MOTION CARRIED.**

Handbook Policy Revisions- Pfister moved, seconded by Ladwig, to change the mileage reimbursement rate from the current rate of 28 cents to the federal rate of 44.5 cents; abolish the lodging rate limitation but monitor charges closely; and leave the meal reimbursement rate at \$35.00/day and include the 15% gratuity. **MOTION CARRIED.**


Employee Assistance Program- Ladwig moved, seconded by Pfister, to approve the contract for employee assistance program with Solution for Life f/k/a EWMH Center. **MOTION CARRIED.**

There being no further business, the meeting adjourned.
