

**COMMISSIONERS' PROCEEDINGS
NIOBRARA COUNTY, WYOMING
MAY 26, 2006**

The Niobrara County Commissioners reconvened for a Special Meeting on May 26, 2006 at 1:30 p.m. in the Commissioners' Room of the Niobrara County Courthouse. The purpose of the meeting was to discuss the OJJDP Grant and set Elected Officials' salaries for the next four-year term. Present were Commissioners Tom L. Wasserburger, Richard A. Ladwig, Ronson B. Pfister and County Clerk Becky L. Freeman.

OJJDP- Donna Messerli, Randy Starkey, Sheriff Rick Zerbe, and Lieutenant Lori Doyle, met with the Commissioners to discuss the OJJDP grant. Messerli gave a brief history of the grant program. She stated that the program was in compliance and had not had any violations in the last five years. She stated the staff was doing a tremendous job.

They also discussed other available grants. Messerli will do further investigation on this and contact Rick or Lori with the information.

Elected Officials' Salaries- Linda Fosher, Elaine Griffith, Keri Thompson, and Rick Zerbe met with the Commissioners and discussed the Elected Officials salaries for the upcoming four-year term. The Commissioners discussed their salaries first. Wasserburger and Pfister want to see a reduction, but Ladwig does not feel a reduction is warranted. Wasserburger moved, Pfister seconded, to adopt **RESOLUTION 06-04—ANNUAL SALARIES FOR ELECTED OFFICIALS** setting the Commissioners salaries at \$12,000 for the next ensuing term. Ladwig voted against the motion. **MOTION CARRIED.**


Ladwig moved, seconded by Wasserburger to adopt **RESOLUTION 06-04—ANNUAL SALARIES FOR ELECTED OFFICIALS** setting the Elected Officials salaries at \$40,000 for the next ensuing term. Pfister voted against the motion. **MOTION CARRIED.**

Pfister moved, seconded by Ladwig, to adopt **RESOLUTION 06-04—ANNUAL SALARIES FOR ELECTED OFFICIALS** setting the salary for full time county attorney at \$35,000. **MOTION CARRIED.**


