

COUNTY COMMISSIONERS' MEETING
NIOBRARA COUNTY, WYOMING
JULY 5, 2011

The Niobrara County Commissioners' meeting was called to order on July 5, 2011 at 9:00 a.m. Those in attendance were Chairman Richard A. Ladwig, Commissioners Arlene Zerbst Rapp, Greg B. Starck, and County Clerk Becky L. Freeman.

Coroner's Building- The Commissioners met with Roger Peterson of Peterson Construction to review his bid submission regarding the Coroner's Office. The Commissioners then met with Ken Keenan of Keenan Construction and Jack Hainey to review Keenan's bid submission for the Coroner's Office.

Legislative Redistricting- Weston County Commissioners and County Clerk (per conference call), Crook County Commissioners and County Clerk, Joe Baron, Crook County Attorney, Hans Hunt, Wyoming State Representative, House District 2, and Ogden Driskill, Wyoming State Senator, Senate District 1 (per conference call) discussed Legislative Redistricting. Representative Hunt presented a proposal for the House Districts and will be submitting it to the State Legislative Committee for their review. Crook, Niobrara and Weston Counties agreed to the proposal presented.

Commissioner Starck left the meeting at 11:20 and returned at 1:30.

Elected Official & Dept. Heads-Clerk of District Court Linda Foshier, County Assessor Elaine Griffith, County Treasurer Keri Thompson, Extension Office Agent Denise E. Smith and County Clerk Becky L. Freeman, met with the Commissioners to discuss county business and items of interest in their departments.

The Commissioners acknowledged receipts for the month of June from the County Clerk for \$6,155.75; from the Sheriff for \$1,027.40 and from the Clerk of Court for \$499.70.

Catering Permits- Commissioner Zerbst Rapp moved, seconded by Commissioner Starck, to approve a catering permit for 3 Sisters to sell alcoholic beverages at the Niobrara County Fairgrounds on July 16, 2011 for the Nelson/Hodge wedding reception. MOTION CARRIED.

Commissioner Zerbst Rapp moved, seconded by Commissioner Starck, to approve three (3) catering permits for The Pub to sell alcoholic beverages at the Niobrara County Fairgrounds on July 7, 8, & 9, 2011 for the Legend of Rawhide Dance. MOTION CARRIED.

Petition to Cross County Roads- Commissioner Starck moved, seconded by Commissioner Zerbst Rapp, to approve a Petition to Cross County Roads submitted by Qwest Corp. MOTION CARRIED.

Coroner's Building Bid Award- Commissioner Zerbst Rapp moved, seconded by Commissioner Starck, to award the bid to Keenan Construction, with a bid amount of \$59,001.26. This bid amount includes alternate 1, installation of a concrete slab in the East/South East portion of the building. MOTION CARRIED.

Minutes- Commissioner Zerbst Rapp moved, seconded by Commissioner Starck, to approve the Minutes of the June 21, 2011 meeting. MOTION CARRIED.

County Attorney- Doyle J. Davies met with the Commissioners and discussed county business.

Contract for Services- Commissioner Zerbst Rapp moved, seconded by Commissioner Starck, to enter into a contract for services with the Town of Lusk for Communication/911/Dispatch Services. MOTION CARRIED.
