

RESOLUTION 02-07

North Jireh Road

WHEREAS, on February 8, 1911 a Petition for a road in Township 33 Range 65, signed by Elmer Campbell and referred to the road supervisor, was submitted to the Commissioners; and

WHEREAS, on March 7, 1911 the County Clerk was instructed to advertise as provided by law; and

WHEREAS, on May 4, 1911 the County Commissioners adopted the following resolution:

“The following road having been advertised as provided by law, and there being no cause for damages filed against it, on motion same is hereby declared a county road.

Beginning at the sw corner of Sec 6 Township 32 on Range line Between 65 & 66 thence north to connection line one mile, thence West on connection line to sw corner of Section 31 Township 33 Range 65 then two miles to sw corner of Section 19 in Township 33 Range 65 and se corner of Section 24 in Township 33 Range 66 making a road two and one half miles due north from the north side of the Town of Jireh, Wyoming.”

WHEREAS, Niobrara County has declined to maintain or improve said road north of the Jireh Cemetery for the past ten (10) years.

NOW, THEREFORE, BE IT RESOLVED that the Niobrara County Commissioners do hereby ratify the existence of said County road as presented on May 4, 1911.

BE IT FURTHER RESOLVED that by so ratifying the road existence Niobrara County is in no way obligated to maintain or improve said county road.

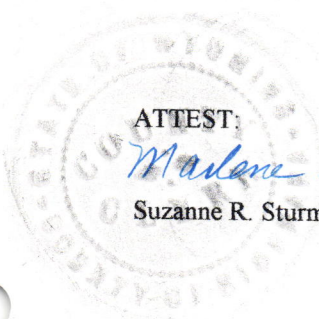

Ratification and Stipulation Agreement

To the Honorable Board of Commissioners of Niobrara County Wyoming.

Whereas on Feb.8, 1911 a Petition for a road in Township 33 Range 65 signed by Elmer Campbell and referred to the road supervisor. was submitted to the Commissioners.

On March 7, 1911 at the Commissioners meeting the clerk was instructed to advertise as provided by law.

On May 4, 1911 at the commissioners meeting, the following resolution was adopted, The following road having been advertised as provided by law, and there being no cause for damages filed against it, on motion same is hereby declared a county road.

Beginning at the sw corner of Sec. 6 Township 32 on Range line between 65 & 66 thence north to connection line one mile, thence west on connection line to sw corner of Section 31 Township 33 Range 65 then two miles to sw corner of Section 19 in Township 33 Range 65 and se corner of Section 24 in Township 33 Range 66 making a road two and one half miles due north from the north side of the Town of Jireh, Wyoming

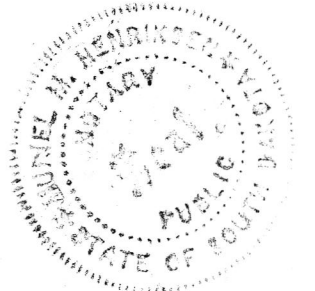
