INSTRUCTIONS TO VOTER**

1. To vote for a person whose name is printed on the ballot, COMPLETELY DARKEN THE OVAL immediately adjacent to the name of the person for whom you desire to vote.
2. To vote for a person whose name is not printed on the ballot, write his name in the blank space provided for that purpose and COMPLETELY DARKEN THE OVAL immediately adjacent to the name of the person.
3. To vote for or against a proposed constitutional amendment, initiative or referendum, or other ballot proposition, COMPLETELY DARKEN THE OVAL immediately adjacent to the proposition marked "For" or "Against" or "Yes" or "No".
4. If you make an error, ask the election official for a new ballot.
5. Use only black ink pen.
