Plates will be issued in consecutive order and forwarded to the County Treasurer's office. Current plates must be surrendered to the Treasurer's office upon issuance of the EMT plates.</p>				
	<p>**<b>Firefighter Plates:</b> A firefighter employed by a city, county, state or duly created fire protection district or a volunteer firefighter must submit a written statement of eligibility preferably on Fire District/Department letterhead, signed by the Fire Chief or designated assistant, to the County Treasurer along with this application before Firefighter Plates or a renewal sticker may be issued. <b>A firefighter retired from his department with at least 10 years of service must obtain a written statement signed only by the fire chief.</b> The approved application, accompanied by a <b>\$30.00 fee made payable to WYDOT</b>, must be remitted to the address at the bottom of the application. Plates will be issued in consecutive order and forwarded to the County Treasurer's office. Current plates must be surrendered to the Treasurer's office upon issuance of the Firefighter plates.</p>
